 - (f) Status of Annual Water Plant Inspections; and
 - (g) Status of the District's Bond Application Report No. 10 in connection with the District's \$5,485,000 Unlimited Tax Bonds, Series 2024 (the "Bonds"), including review of Order of the Texas Commission on Environmental Quality authorizing issuance of same, and discussion regarding timing of the sale of the Bonds;
