NOTICE OF PUBLIC MEETING

Notice is hereby given to all interested members of the public that the Board of Directors of the above captioned District will hold a regular public meeting at 13325 ½ Kuykendahl, Houston, Harris County, Texas 77090, said address being a meeting place of the District.

The meeting will be held on Tuesday, June 18, 2024, at 5:30 p.m.

The Board shall consider and discuss the following matters and take any action appropriate with respect to such matters:

1. Public comments;
2. Discuss appointment of a new director to fill the vacancy on the Board;
3. Review and approve the minutes of May 28, 2024, Board of Directors meeting;
4. Harris County Constable's Office Security Report, including security issues within the District;
5. Bookkeeper's report, including financial investment reports, and authorizing the payment of invoices presented;
6. Tax Assessor-Collector report, including status of delinquent tax accounts, authorizing the payment of invoices presented, approving tax refunds and moving of accounts to uncollectible roll;
7. Report and legal action taken by the District's delinquent tax collections attorney, authorize foreclosure proceedings, installment agreements, the filing of proofs of claim and approval of service terminations;
8. Operation and maintenance report, including:
 - (a) Authorizing the repair and maintenance of District facilities;
 - (b) Any appeals of District charges; and
 - (c) Approve write-off of uncollectible accounts, including report concerning year to date total for uncollectable accounts;

9. Engineering report, including:
 - (a) Authorizing the design, advertisement for or solicitation of bids and/or award of construction contracts or concurrence in the award of a contract for the construction and/or repair of water, sanitary sewer and drainage facilities within the District; status of construction contracts, including the approval of any change orders; and/or acceptance of facilities for operation and maintenance purposes and acceptance of site and/or easement conveyances for facilities constructed or to be constructed for the District, including:
 - (i) Water Plant No. 1 HPT Nos. 1 and 2 Replacement – CFG Industries;
 - (ii) Wastewater Treatment Plant Rehabilitation; and
 - (iii) Emergency Water Well Repairs;
 - (b) Discussion regarding E. Coli monitoring;
 - (c) Discussion regarding tests being conducted to determine the arsenic and iron levels in the District's water supply;
 - (d) Wastewater Treatment Plant, including proposal for platting;
 - (e) Status of TPDES Major Permit Amendment;
 - (f) Status of preparation of Bond Application Report No. 10; consider adoption of Order Authorizing Application for Approval of Project and Bonds and authorizing filing of same with the Texas Commission on Environmental Quality;
 - (g) Status of Annual Water Plant Inspections; and
 - (h) Temporary Wastewater Capacity Request from Harris County Municipal Utility District No. 58;
10. Fifth Addendum and Amendment to Waste Disposal Contract between the District and Harris County Municipal Utility District No. 215;
11. Amended and Restated Master Service Agreement with Storm Water Solutions, LLC;
12. Issuance of utility commitments;
13. Matters related to the Central Harris County Regional Water Authority;
14. Communications Report, including discussion regarding website and messaging services, and take any action necessary and appropriate in connection therewith;
15. Authorize completion, execution and filing with the Secretary of State of Voting System Annual Filing Form relative to District elections;
16. Attorney's Report;
17. Convene executive session pursuant to Open Meetings Act, Texas Government Code Section 551.071 (consultation with attorney), and/or Section 551.072 (acquisition of real property or interests therein);

18. Reconvene in open session; authorize the taking of any action resulting from deliberations in executive session; and
19. Matters for possible placement of future agendas.
