WASTEWATER TREATMENT PLANT REPLACEMENT CONCEPTUAL DESIGN WORKSHOP

Following introductions, Mr. Dunn presented and reviewed a presentation regarding the conceptual design of the 1.44 MGD wastewater treatment plant ("WWTP") replacement project, a copy of which is attached hereto as **Exhibit A**.

Discussions ensued regarding the site layout for the WWTP, the scope changes and cost estimates for the WWTP replacement project, the process flow diagrams, the hydraulic profile, the process conceptual layouts, the equipment manufacturers, and the prosed design and construction schedules.

During said discussions, Mr. Dunn and Mr. Abshire responded to questions regarding flooding concerns, the type of generator to be installed at the WWTP site, the location of the vendors and where equipment will be manufactured, and whether a SCADA system will be

installed at the WWTP. Mr. Abshire advised that additional analysis will be performed to determine the type of generator to be installed.

Following discussion, upon motion made by Director Wright, and seconded by Director Wilson, the Board unanimously voted to adjourn the meeting.
